37.60 feet (said curve having a long chord whose bearing is North 20 degrees 49 minutes 25 seconds East and a length of 37.60 feet) to a concrete monument; thence, continuing along said right-of-way line (said right-of-way line becoming a variable right-of-way at this point) North 33 degrees 22 minutes 16 seconds East a distance of 270.03 feet to a concrete monument located at the intersection of the southeasterly right-of-way line of Haywood Road and the southerly right-of-way line of Congaree Road (said right-of-way being an 80 foot right-of-way at this point); thence along said right-of-way line of Congaree Road, the following courses and distances: in curvature to the right a distance of 100.04 feet (said curve having along chord whose bearing is North 74 degrees 48 minutes 43 seconds East and a length of 99.95 feet) to an iron pin; in curvature to the right a distance of 25.00 feet (said curve having a long chord whose bearing is North 82 degrees 46 minutes 20 seconds East and a length of 25.00 feet) to an iron pin; thence leaving said right-of-way line and following the boundary line of property now or formerly owned by New South Development Co., the following courses and distances: South 33 degrees 20 minutes 00 seconds East a distance of 308.00 feet to a point; North 75 degrees 40 minutes 36 seconds East a distance of 112.37 feet to a point; North 87 degrees 18 minutes 58 seconds East a distance of 192.21 feet to a point; North 29 degrees 20 minutes 35 seconds East a distance of 104.49 feet to an iron pin located on the southerly right-of-way line of Congaree Road (a 80 foot right-of-way at this point); thence along said right-of-way line, the following courses and distances: in curvature to the right a distance of 21.99 feet (said curve having a long chord whose bearing is South 54 degrees 27 minutes 42 seconds East and a length of 21.99 feet) to an iron pin; in curvature to the right a distance of 140.53 feet (said curve having a long chord whose bearing is South 48 degrees 49 minutes 45 seconds East and length of 140.28 feet) to an iron pin; North 34 degrees 14 minutes 29 seconds East a distance of 15.00 feet to an iron pin (said right-of-way line becoming 25.00 feet from the centerline of Congaree Road at this point); thence along said right-of-way line, the following courses and distances: South 47 degrees 47 minutes 10 seconds East a distance of 396.48 feet to an iron pin; South 45 degrees 10 minutes 47 seconds East a distance of 200.19 feet to an iron pin; South 42 degrees 05 minutes 54 seconds East a distance of 195.78 feet to an iron pin; South 38 degrees 37 minutes 47 seconds East a distance of 200.00 feet to an iron pin; South 36 degrees 58 minutes 47 seconds East a distance of 133.00 feet to an iron pin; North 84 degrees 50 minutes 11 seconds East a distance of 28.50 feet to a nailing cap in the centerline of Congaree Road; thence along the said centerline, South 35 degrees 36 minutes 32 seconds East a distance of 230.79 feet to a nailing cap; thence leaving said centerline, South 53 degrees 32 minutes 13 seconds West a distance of 418.19 feet to a point; thence South 36 degrees 30 minutes 20 seconds East a distance of 271.02 feet to a nailing cap and the TRUE POINT OF BEGINNING.
