release unto **BEN C. SANDERS**, his heirs and assigns forever:

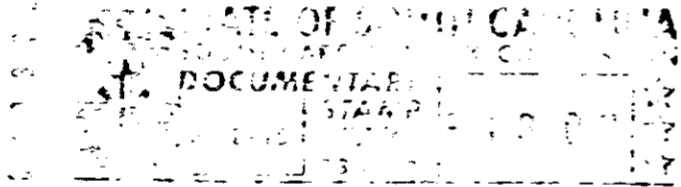
