RENZOR O. WILSON, his heirs and assigns forever, all our right, title and interest in and to

ALL that piece, parcel or tract of land with all improvements thereon or hereafter constructed thereon situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as Tract 4, containing 1.87 acres as shown on plat of Property of Mrs. Loraine Wilson made by C. O. Riddle, Engineer, February 25, 1976, and having according to said plat the following courses and distances:

BEGINNING at iron pin on a 50-foot street and a circled driveway at the corner of Tract 4 and running thence with the circle, the chord of which is N. 13-56 E. 55.56 feet to iron pin; running thence continuing with said circle N. 53-34 W. 55.56 feet to iron pin in the center of a 10-foot drainage easement; running thence along the joint line of Tracts 3 and 4 and the center of the said 10-foot drainage easement N. 11-13 W. 406.8 feet to iron pin; running thence along land now or formerly of Charles M. Forest, Jr., S. 58-12 E. 450.7 feet to iron pin; running thence S. 47-40 W. 368.75 feet to the beginning corner.
