**Know all Men by these presents, That** We, J. H. McINTYRE, individually, and J. H. McINTYRE, GERALDINE McINTYRE ROSS, ROBERT LEE McINTYRE, HENRY ELLA McINTYRE WATKINS and JEROME McINTYRE, constituting all the heirs at law of BLANCHE D. McINTYRE, deceased,

in the State aforesaid,

in consideration of the sum of Forty Thousand and No/100 (\$40,000.00)----- Dollars

to us paid by Herbert Campbell and Lucille Doggette Campbell

in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

HERBERT CAMPBELL and LUCILLE DOGGETTE CAMPBELL, their heirs and assigns forever:

ALL that piece, parcel or lot of land in Greenville Township, Greenville, County, State of South Carolina, with all buildings and improvements thereon situate on the Northeast side of Harrington Avenue in the City of Greenville, being shown as Lot No. 90 on a plat of Isaqueena Park made by Pickell and Pickell, June 3, 1947, recorded in Plat Book P, at pages 130 and 131 and described as follows:

BEGINNING at a stake on the Northeast side of Harrington Avenue, 350 feet Southeast from Oxford Street at corner of Lot 89 and running thence with the line of said lot, North 39-25 East 175 feet to a stake; thence South 50-35 East 70 feet to a stake in line of Lot 46; thence with the lines of Lots 46, 47 and 48, South 39-25 West 175 feet to a stake on Harrington Avenue; thence with the Northeast side of Harrington Avenue, North 50-35 West 70 feet to the beginning corner.

ALSO, all that certain piece, parcel or lot of land in the City of Greenville, County and State aforesaid, known and designated as the Southern one-half of Lot No. 89 of Isaqueena Park, according to plat recorded in Plat Book P, at pages 130 and 131 and described as follows:

BEGINNING at an iron pin on the Eastern side of Harrington Avenue at the joint front corner of Lots 89 and 90 and running thence with Harrington Avenue, N. 50-35 West 35 feet to a point; thence North 39-25 East 175 feet to a point; thence South 50-35 East 35 feet to a point; thence South 39-25 West 175 feet to the point of beginning.
