KNOW ALL MEN BY THESE PRESENTS, that I, Thomas C. Few

in consideration of Ten (\$10.00) love and affection for my grand-niece Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto SHIRLEY T. BENNETT, her heirs and assigns:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, Schook District 6-E, being known and designated as all of Lot No. 13, and the southern portion of Lot No. 12, of a subdivision known as CASTLE PARK as shown on Map 1 thereof recorded in the RMC Office for Greenville County in Plat Book G at page 225, and having the following metes and bounds, to-wit:

Beginning at an iron pin on the west side of Washington Avenue in the front line of Lot No. 12 at a point 330 feet south of the southwest corner of the intersection of Flora Avenue and Washington Avenue, and running thence along the west side of Washington Avenue, S. 21-55 E. 90 feet to an iron pin at the corner of Lot No. 14; thence along the line of that lot N. 67-48 E. 225.6 feet to an iron pin at the rear corner of said lot on an alley; thence along the line of said alley, N. 21-27 W. 90 feet to an iron pin at a point 20 feet north of the rear corner of Lots Nos. 12 & 13; thence on a line parallel with the joint line of Lots Nos. 12 & 13, and at all times 20 feet north thereof, S. 67-48 W. 225 feet to an iron pin on the west side of Washington Avenue, the beginning corner.
