release unto BRUCE W. COOKE and ARLENE K. COOKE, their Heirs and Assigns forever:

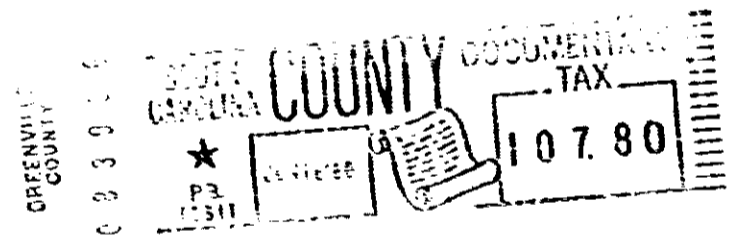
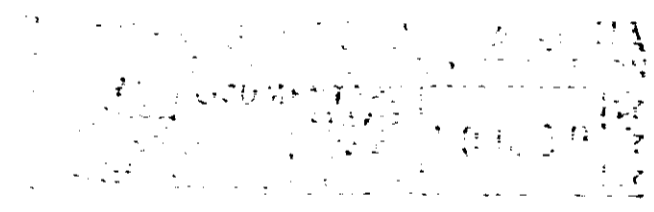
ALL that certain piece, parcel, or lot of land with the buildings and improvements
