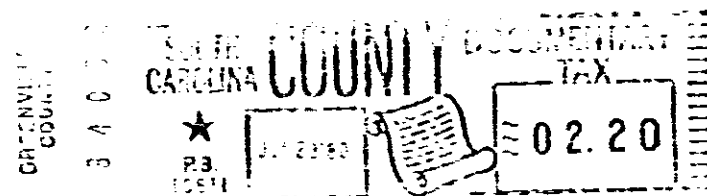
All our undivided interest in and to the following described property:
