the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto JOHN A. BOLEN, INC., its successors and assigns, forever:

ALL that certain piece, parcel or lot of land situate, lying and being in the Greenville County, State of South Carolina, in the City of Mauldin, being known and designated as Lot No. 48, Section I of FORRESTER WOODS Subdivision, as shown on plat prepared by R.B. Bruce, R.L.S., recorded in the RMC Office for Greenville County in Plat Book 4N at page 78 and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Boulder Road at the joint front corners of Lots Nos. 45 and 48 and running thence with the common line of said lot S. 62-24 E. 140 feet to an iron pin; thence with the rear line of Lot No. 47 S. 27-36 W. 115 feet to an iron pin at the joint front rear corners of Lots Nos. 48 and 49; thence with the common line of said lots N. 62-24 W. 140 feet to an iron pin on the eastern side of Boulder Road; thence with the eastern side of Boulder Road N. 27-36 E. 115 feet to the point of beginning. This conveyance is made subject to any restrictive covenants, building setback lines, easements and rights of way affecting the above described property.

This is the same property conveyed to the grantors herein by deed of Susan Z. Madden recorded in the RMC Office for Greenville County 2/28/80 in Deed Book 1051 at page 777.
