All that certain piece, parcel or lot of land with the buildings and improvements thereon lying and being on the northwesterly side of Creekside Road, near the City of Greenville, South Carolina, and being designated as Lot No. 430 on Map Three, Section Two, Sugar Creek, as recorded in the RMC Office in Plat Book 7X, at page 2, and having, according to said plat, the following metes and bounds, to-wit:
