ALL that certain piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, on the eastern side of Shadow Lane, in a subdivision known as Super Highway Home Sites, being known and designated as Lot No. 59 of said subdivision, and being described according to a plat of Super Highway Home Sites, prepared by Dalton & Neves, Engineers, dated May 1946, and recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book P, at Page 53. The property herein conveyed has, according to said plat, the following mates and bounds, courses and distances, to-wit:

BEGINNING at an iron pin on the eastern side of Shadow Lane, at the joint front corner of Lots 59 and 60, and running thence along the common line of said lots, N. 80-17 E. 146.6 feet to an iron pin; thence S. 30-30 E. 137 feet to an iron pin, the joint rear corner of Lots Nos. 58 and 59; thence along the common line of said last mentioned lot, S. 88-0 W. 194.4 feet to an iron pin on the eastern side of Shadow Lane; thence along the eastern side of Shadow Lane N. 11-0 W. 102 feet to an iron pin, the beginning corner.

EXCEPTING, a five (5) foot strip at the rear of each lot in this subdivision is reserved for utilities.
