ALL those certain pieces, parcels or lots of land situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as portions of lots numbered 67 and 68 of Sylvan Hills, on plat recorded in Plat Book S on Plat 03 and being more particularly shown on plat entitled "Property of T.V. Crosby", prepared by Freeland & Associates, dated February 25, 1931, recorded in Plat Book 8-M at Page 8 of the REC Office for Greenville County, and having according to said plat the following metes and bounds, to-wit:
