

HUNDRED AND NO/100----- (\$15,500.00)----- Dollars.

The receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and  
release unto HARRIE P. WELLS, HER HEIRS AND ASSIGNS FOREVER:

ALL that piece, parcel or lot of land situate, lying and being near the City of Greenville,  
State of South Carolina, and known and designated as Lot #136, part of Avon Park, according  
to plat prepared by C. C. Jones, dated December 1956, plat of which is recorded in the Office  
for Greenville County in Plat Book KK, at page 71, and has the following rates and  
bounds, to-wit:

BEGINNING at an iron pin on the southeast side of Avon Drive and running thence from the  
joint front corner of lots #136 and #137 52'-0" 20' to an iron pin; thence 76'-5 1/2" 80' to  
an iron pin at the joint rear corner of lots #136 and #135; running thence 82'-0" 200' to  
an iron pin on the southeast side of Avon Drive; thence running along the southeast side of  
Avon Drive 86'-5 1/2" 80' to an iron pin, point of beginning.
