KNOW ALL MEN BY THESE PRESENTS, that I, KATHARINE BUSH EDWARDS WYMAN (formerly Katharine Bush Edwards)(hereinafter referred to as Grantor)

in consideration of ONE and No/100 (\$1.00) ----- Dollars,

and love and affection for Thomas W. Edwards, Jr. the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto THOMAS W. EDWARDS, JR. (hereinafter referred to as Grantee), his heirs and assigns forever, a remainder interest in and to an undivided SEVENTY FIVE PER CENT (75%) interest in and to the herein described properties, subject only to the Grantor's right to convey by sale all or any part of the SEVENTY FIVE PER CENT (75%) undivided interest in fee simple provided the interest is sold to a purchaser who pays the current fair market value for the real estate conveyed. Grantor agrees that any liens or encumbrances on the property which she has created or which arise during her lifetime or as of her death will be paid by her estate. Upon the death of Katharine Bush Edwards Wyman any and all of the remaining unsold portion of the SEVENTY FIVE PER CENT (75%) undivided interest described above in the herein described properties will be solely owned by Thomas W. Edwards, Jr., his heirs and assigns forever absolutely and in fee simple title free and clear of all liens and encumbrances including those created at and after the death of Katharine Bush Edwards Wyman. Supplementary covenants and restrictions are listed on the back of this deed. The subject properties are described as follows: ALL that piece, parcel or lot of land in the City of Greenville, Greenville County, State of South Carolina in a subdivision known as Alta Vista, and being more fully described according to a plat of the aforementioned subdivision by Dalton and Neves, recorded in Plat Book G at page 20 in the R.M.C. Office for Greenville County as follows:

BEGINNING at an iron pin on the southwest corner of the intersection of McIver and Belmont Streets, running thence S. 4-15 W. 102' thence N. 84-35 W. 164.75', thence N. 4-15 E. 102' to a point on the south side of McIver Street; thence S. 84-35 E 164.75' to the beginning corner; the above described lot being Lot # 7 and a portion of Lot # 8.

The foregoing real estate being a portion of the property conveyed to Katharine Bush Edwards September 11, 1959 by deed of the South Carolina National Bank of Charleston recorded at pages 211 and 212 and deed of Katharine Mckinnon Wilkinson recorded at page 208. The foregoing deeds

together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee(s)' heirs or successors and assigns, forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor(s)' heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee(s)' heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
