Cothran & Darby Builders, Inc., Its successors and assigns, forever:

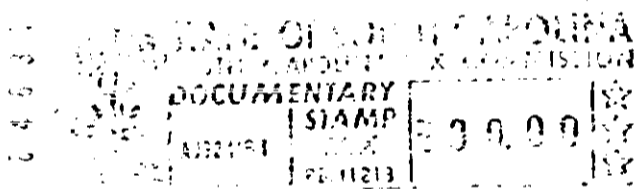
