

ALL that certain piece, parcel or lot of land with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, known as Lot #4 Maxwell Heights Subdivision as shown on Tax Assessors Map as WG1.4, Section #1, Plot # 149, located on Deacon Street in the Gantt Township; shown on a Plat of William Maxwell Property, recorded in Plat Book BBB on Page 131, Office of the R.M.C. for Greenville County; now shown as Property of Robert Walker on a Plat by Freeland and Associates RLS, dated July 16, 1981, and having according to said Plat the 14 (156) WG 1.4-1-149 following metes and bounds:
