the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Nancy Bridwell, her heirs and assigns forever, All my interest in the lot of land as described below.

ALL that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Chick Springs Township, about one mile north of Chicks Springs, lying on the north side of Rock Crest Drive, and being triangular in shape, being bounded on the northeast by lands formerly of McConnell, on the northwest by lands of G. F. Belcher, and on the south by the said road or drive, and being a part of the same property conveyed to E. W. Evington by deed recorded in the R. M. C. office for Greenville County in Deed Book I6I at page 552, and having the following courses and distances, to-wit:
