Pipe, 220 feet, more or less of 2" Galv. Pipe, six 6" valves, four 2" valves, and one Fire Hydrant as is shown on a drawing entitled "The Fortis Corporation to Commissioners of Public Works of the City of Greenville, S.C." dated March 1981, attached hereto and made a part of this conveyance.
