- 3. The property referred to by this agreement is described as follows: All that lot of land in the County of Greenville, State of S. C., near Greenville, S. C., shown as lot 99 on plat of Fresh Meadow Farms recorded in the R.M.C. Office in plat book "Y", page 55, and having the following metes and bounds, to-wit: Peginning at an iron pin on the eastern side of High Valley Boulevard, at the corner of lot 100, and running thence along the Boulevard N 3'-15 E 70 feet to an iron pin; thence S 57-15 E E 175 Feet to an iron pin; thence S 32-15 W 70 feet to an iron pin; thence N 57-15 W 175 feet to the point of beginning. Upon payment of all indebtedness of the undersigned to Bank this agreement shall be and become void and of no effect, and until then it shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and assigns, and inure to the benefit of Bank and its successors and assigns. The affidavit of any officer or department manager of Bank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to rely thereon.
