The property referred to by this agreement is described as follows: All that piece, parcel or lot of land, with all buildings and improvements thereon, situate, lying and being on the southeastern side of Williams Street, in the Town of Travelers Rest, Greenville County, SC being known and designated as Lot No. 14 on a plat entitled "Revision of Lots 11 through 16 T. Walter Brashier Property." made by Webb Surveying Company, dated March 1, 1974, recorded in the RMC Office for Greenville County, SC, in Plat Book 5-D at Page 32, and having according to said plat, the following metes and bounds, to-wit: Beginning at an iron pin on the southeeastern side of Williams Street, at the corner of Lot No. 15, which iron pin is situate 191 feet north of the property of Duncan, and running thence along said street, N. 54-37 E 97 feet to an from pin; thence S. 33-42 E 535.3 feet to an iron pin; thence S 87-50 W 65.7 feet to an iron pin; thence N. 30-53 W 171.6 feet to an iron pin; thence N. 41-49 W 330 feet to the point of beginning. This being the identical property conveyed to the grantor herein by (Over) That if default be made in the performance of any of the terms hereof, or if default be made in any payment of principal or interest, on any notes hereof or hereafter signed by the undersigned, the undersigned agrees and does hereby assign the rents and profits arising or to arise from said premises to the Bank and agrees that any judge of jurisdiction may, at chambers or otherwise, appoint arising or to arise from said premises to the Bank and agrees that any judge of jurisdiction may, at chambers or otherwise, appoint a receiver of the described premises, with full authority to take possession thereof and collect the rents and profits and hold the same subject to the further order of said court.
- 4. That if default be made in the performance of any of the terms hereof, or if any of said rental or other sums be not paid to Bank when due, Bank, at its election, may declare the entire remaining unpaid principal and interest of any obligation or indebtedness then remaining unpaid to Bank to be due and payable forthwith.
- 5. That Bank may and is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places as Bank, in its discretion, may elect.
- 6. Upon payment of all indebtedness of the undersigned to Bank this agreement shall be and become void and of no effect, and until then it shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and assigns, and inure to the benefit of Bank and its successors and assigns. The affidavit of any officer or department manager of Bank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to rely thereon.
