ALL that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, at the Southwest corner of the intersection of Palmetto Avenue and Green Street and being shown as Lot No. 10, Block U, on plat of Riverside Land Company, recorded in Plat Book A, at page 323, and re-platted in Plat Book K, at page 282, RMC Office for Greenville County.

BEGINNING at an iron pin at the Southwest corner of the intersection of Palmetto Avenue and Green Street and running thence with the western side of Green Street, S. 10-15 W. 125 feet to iron pin on a 15-foot alley; thence with the North side of said Alley, N. 79-45 W. 50 feet to an iron pin, corner of Lot No. 9; thence with the line of Lot No. 9, N. 10-15 E. 125 feet to an iron pin on Palmetto Avenue; thence with the southern side of Palmetto Avenue, S. 79-45 E. 50 feet to the point of beginning.
