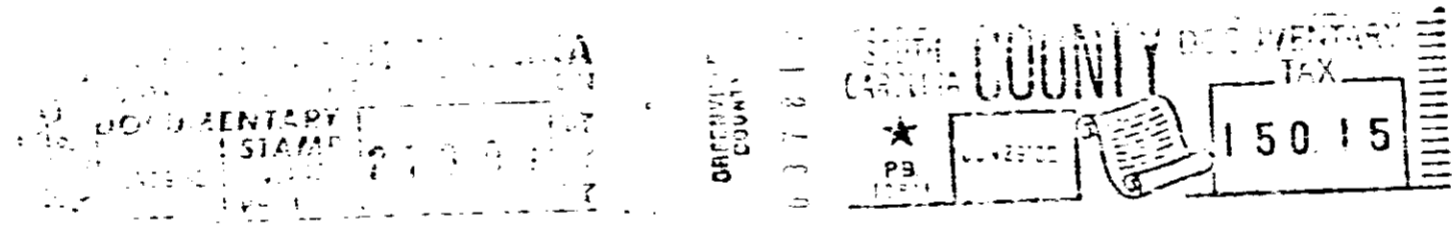
KNOW ALL MEN BY THESE PRESENTS, that Cothran & Darby Builders, Inc.

the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and
release unto James F. Zickos and Susan A. Zickos, their heirs and assigns
forever:

ALL that certain piece, parcel or lot of land, with the buildings and improvements thereon,
lying and being on the westerly side of Ladyslipper Lane, near the City of Greenville,
South Carolina, being known and designated as Lot No. 513 on plat entitled, "Map Four,
Section Two, Sugar Creek" as recorded in the R.M.C. Office for Greenville County, SC
in Plat Book 8P at Page 62, and having, according to said plat, the following metes and
bounds, to-wit: — 11 - 195 - 538, 17 - 1 - 5

BEGINNING at an iron pin on the westerly side of Ladyslipper Lane, said pin being the
joint front corner of Lot No. 513 and 514 and running thence with the common line of said
lots, N. 71-55 W. 156.23 feet to an iron pin at the joint rear corner of Lot Nos. 513 and
514; thence N. 34-28-06 E. 205.20 feet to an iron pin at the joint rear corner of Lot Nos.
512 and 513; thence with the common line of said lots S. 18-55 E. 196.50 feet to an iron
pin on the westerly side of Ladyslipper Lane; thence with the westerly side of Ladyslipper
Lane, on a curve, the chord of which is S. 44-35 W. 44.62 feet to an iron pin, the point
of beginning.
