the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto DARNELL D. DANIELEY AND MARY ANN DANIELEY, their heirs and assigns  
forever;

ALL that certain piece, parcel or lot of land situate, lying and  
being in the County of Greenville, State of South Carolina, and  
being shown and designated as Lots 10 (2.03 acres) and 11 (1.51 acres)  
on a proposed plat for William G. Gallman recorded in Plat Book 9-A  
at Page 60, R.M.C. Office, Greenville County, South Carolina, reference  
being made to said plat for a more particular description thereof.

LESS, HOWEVER, that portion of the above described property located  
within the right-of-way of said fifty (50') foot private road.

ALSO, CONVEYED HEREIN is an undivided two-wlwwnths (2/11ths) interest  
in and to that portion of the said fifty (50') foot private road  
abutting said Lots Nos. 10 and 11, together with a permanent easement  
in said fifty (50') foot private road for the purpose of ingress and  
egress to all lots on the aforesaid plat abutting said private road  
and for the purpose of installing, maintaining and repairing a water  
line within said right-of-way of said private road. Said easement shall  
run with the said real property described as Lots Nos. 10 and 11 and  
shall be binding on the Grantor herein, their heirs and assigns.
