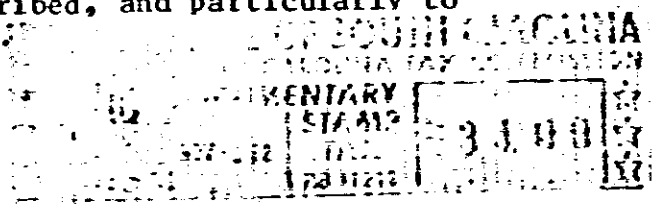

BEGINNING at an iron pin on the northerly side of Hunting Hill Circle, said pin being the joint front corner of Lots 519 and 520, and running thence with the common line of said lots N. 26-27-26 W. 227.42 feet to an iron pin at the joint rear corner of Lots 519 and 520; thence N. 29-25 E. 142.09 feet to an iron pin; thence S. 61-33 E. 60.14 feet to an iron pin, the joint rear corner of Lots 518 and 519; thence with the common line of lots S. 10-16-09 E. 279.57 feet to an iron pin on the northerly side of Hunting Hill Circle; thence with the northerly side of Hunting Hill Circle S. 71-38-13 W. 75 feet to an iron pin at the point of beginning.
