A Corporation chartered under the laws of the state of South Carolina and having a principal place of business at Greenville, State of South Carolina, in consideration of Five Thousand and no/100 (\$5,000.00) ----- Dollars,

the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto

JAMES A. CHURCH and BERTIE D. CHURCH, their heirs and assigns:

ALL that piece, parcel or tract of land, situate, lying and being off the northern side of the Chandler Road, in Oaklawn Township, Greenville County, South Carolina, being a portion of the W.C. HOPKINS ESTATE, bounded by Joe T. Nicholson, Stone and others, and having according to a survey for SOUTHEASTERN LAND COMPANY made by James R. McClure, R.L.S., dated October 20, 1982, containing Two (2.0) acres, more or less, and having according to said plat the following metes and bounds, to-wit: (22)-45-596.5-1-9
