IT BEING understood that the water mains located in and serving Swansgate and being on the property of the Grantor shall and do remain the property of the Grantor and the Grantor shall be fully responsible for the maintenance thereof.

And, the grantor does hereby bind itself and its successors to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee's(s') heirs or successors and against every person whomsoever lawfully claiming or to claim the same of any part thereof.
