the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Darrell W. Harrison and Georgia G. Harrison, their heirs and assigns forever:

ALL that piece, parcel or tract of land in Paris Mountain Township, Greenville County, State of South Carolina, situate, lying and being on the southeastern side of Little Texas Road containing 4.9 acres and being more particularly described according to plat of Property of P. B. Marchbanks by C. F. Webb, Surveyor, date March 1959 and recorded in the RMC Office for Greenville County in Plat Book SS at Page 131, as follows:

BEGINNING at a point in the center of Little Texas Road in the line of property of Peter B.
