release unto Nancie E. Dixon and J. Kelly Dixon, their heirs and assigns, forever:

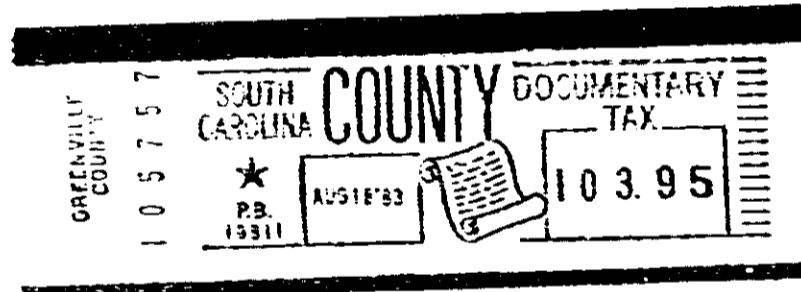
All that certain piece, parcel or lot of land known and designated as Lot No. 5,
