A non-exclusive right-of-way for a drive way for the purpose of ingress and egress from Devenger Road to the 1 acre tract of land described in a deed from Bobby Clyde Jenkins, Thomas Posey Jenkins and Francis Gilreath Jenkins to Betty Sue Jenkins Webb dated September 20, 1983, and shown on a plat of "Estate of Annie L. Jenkins" recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 9-Z at Page 16.
