the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto William A. Parnell, his heirs and assigns, forever:

ALL that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on both sides of Trammell Bridge Road and being shown and designated as Tract No. 6, on a plat of survey prepared by Robert R. Spearman, RLS, No. 3615, dated August 16, 1983, and recorded in the RMC Office for Greenville County in Plat Book 10-I, Page 16, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a nail and cap in the center of Trammell Bridge Road at the joint corner with Tract No. 2 and running thence N. 16-56 W. 594.55 feet to an iron pin; thence S. 84-47 W. 311.91 feet to an old iron pin and continuing along the same line 415.0 feet to an iron pin to a point in the center of the river as it flows underneath the bridge; thence with the center of the river as the line and running approximately S. 17-36 E. 236.24 feet to a point; thence S. 41-01 E. 192.19 feet to a point; thence S. 19-17 E. 187.67 feet to a point in the river; thence leaving the river N. 48-07 E. 314.75 feet to a nail and cap in Trammell Bridge Road; thence along the road S. 47-32 E. 22.06 feet to a nail and cap; thence leaving the road N. 34-17 E. 187.04 feet to an iron pin; thence S. 53-48 E. 181.0 feet to an iron pin; thence S. 22-32 W. 195.0 feet to a nail and cap in the center of Trammell Bridge Road; thence with the road S. 78-19 E. 95.92 feet to a nail and cap; thence N. 89-24 E. 116.46 feet to a nail and cap at the point of beginning and containing 7.77 acres, more or less including all rights-of-way.
