more complete description by metes and bounds.

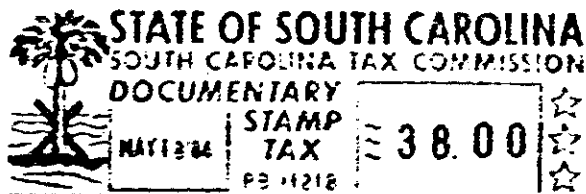
This is a portion of the property conveyed to the Grantor by YB Developers, Inc. by

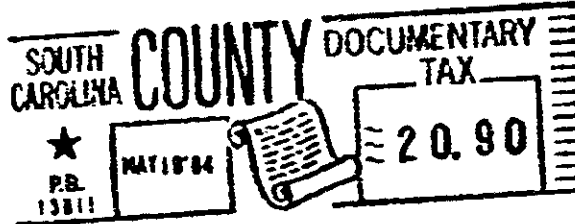
