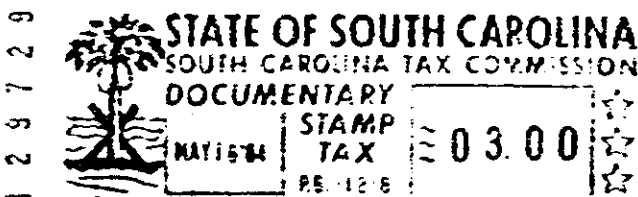

Pierce, his heirs and assigns forever all that piece, parcel, or lot of land in Glassy Mountain Township, Greenville County, South Carolina, shown and designated as Lot No. 39 and Lot No. 40 on plat made for Joe J. Gentry, by J. Q. Bruce, R.L.S. October 13, 1962, showing courses and distances as follows:

Beginning on an iron pin at corner of Lots Nos. 11, 26, 39, and 40, in center of road leading from Butterstreet through the Gentry Subdivision end running North 60-30, West 200 feet to an iron pin at corner of Lot No. 9; thence with line of Lot No. 9 North 24-00 East 322 feet to a pin near the center of Subdivision Road; thence South 61-30 East 80 feet; thence with line of Lot No. 40 South 4-20 West 360 feet to the beginning. This is Lot 39.

Lot No. 40: Beginning on an iron pin at corner of Lots Nos. 11, 26, 39, and 40, in center of road leading from Butterstreet through Gentry Subdivision and running with line of Lot No. 39 North 4-20 East 360 feet to an iron pin in road at corner of Lot No. 10; thence with line of Lot No. 10 North 46-40 East 137.3 feet to an iron pin at corner of Lot No. 38; thence with line of Lots No. 38, 12, and 13 South 10-00 East 337 feet to an iron pin at corner of Lot No. 11; thence with line of Lot No. 11 South 56-00 West 220 feet to the beginning.
