in consideration of Fourteen Thousand and No/100-----(\$14,000.00)-----Dollars,

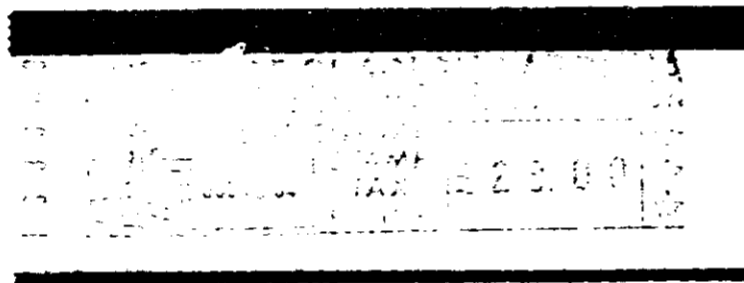
