To deposit in my name and for my account, with any bank, banker, or trust company or any building or savings and loan association or any other banking or similar institution, all monies to which I am entitled or which may come into Attorney's hands as such attorney in fact, and all bills of exchange, drafts, checks, promissory notes, and other securities for money payable belonging to me, and for that purpose to sign my name and endorse each and every such instrument for deposit or collection; and from time to time, or at any time, to withdraw any or all monies deposited to my credit in any bank, banker, or trust company or any building or savings and loan association or any other banking or similar institution having monies belonging to me, and, in connection therewith, to draw checks or to make withdrawals in my name; to make, do, execute, and acknowledge, and deliver, for any upon my behalf and in my name, all such checks, notes, and contracts;

12. To endorse, receive, and deposit and/or collect checks payable to my order drawn on the treasurer or other fiscal officer or depository of the United States, or any sovereign state or authority, or any political subdivision or instrumentality thereof, or to any private person, firm, corporation, or partnership;

13. To have access at any time or times to any safe deposit box rented by me, wheresoever located, and to remove all or any part of the contents thereof, and to surrender or relinquish said safe deposit box, in any institution in which any such safe deposit box may be located shall not incur liability to
