ALL that piece, parcel or lot of land situate, lying and being on the Southwestern side of Geer Highway (Highway 276), near the City of Greenville, in the County of Greenville, State of South Carolina, and shown on a plat prepared by R. B. Bruce, R.L.S. dated January 30, 1981, and recorded in the R.M.C. Office for Greenville County in Plat Book 8L at Page 46, and, according to said plat, has the following metes and bounds, to-wit:
