THIS is a portion of a tract conveyed to the late H. M. Fitts and Ruby M. Fitts (same as Marcelle F. Fitts) by deed of C. A. Edwards, recorded on August 31, 1944 in Deed Book 267 at page 5, The said H. M. Fitts died testate on July 11, 1977, as will appear by reference to the estate records on file in the Greenville County Probate Court. Under the terms of his Will, the said H. M. Fitts attempted to make various specific devises of portions of the subject property on which the legal descriptions were not well-defined or consistant with subsequent conveyances out of the original tract.
