

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Lewis L. Bradham and Marilyn J. Bradham, their heirs and assigns, forever:

All that piece, parcel or lot of land situate, lying and being on the Northern side of Hiavatha Drive, near the City of Greenville, in the County of Greenville, State of South Carolina, known and designated as Lot No. 206 of a subdivision known as Sector 5, Botany Woods, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book YY at pages 6 and 7, and having, according to said plat, the following metes and bounds: -12 - 271 - P15, 13 - 1 - 162
