THE Grantee and its successors and assigns are hereby granted the nonexclusive easement and/or right to the use of the existing retention pond as shown on said plat above referred and more fully described hereinbelow, for the purpose of controlling surface water on the 11.93 acre tract herein conveyed. The Grantor herein specifically agrees that the maintenance of said existing retention pond shall be the sole responsibility of the Grantor, his heirs and assigns, and further agrees that it is the intent of this instrument and the parties hereto that this nonexclusive easement and/or right to the use of the existing retention pond shall be an easement appurtenant and perpetual and shall run with the land and inure to the benefit of the Grantee herein, its successors and assigns forever. ALL that piece, parcel or lot of land situate, lying and being north of Rutherford Road, in the County of Greenville, State of South Carolina, and shown on a survey for T. Walter Brashier dated September 1984 as an existing retention pond and, according to said plat, has the following metes and bounds, to-wit:
