

Patrick Saffery to William Bonds, acknowledged in open court by the said Pa-  
trick Saffery and ordered to be recorded.

This Indenture made this third day of November in the year of our Lord  
One thousand Seven hundred and eighty nine, Between Patrick Saffery of  
Greenville County and State of South Carolina of the one part, and William  
Bonds of the said State and County of the other part, *Witneseth* that the said  
Patrick Saffery for and in consideration of the sum of one hundred and ten  
pounds lawful Sterling money to him in hand well and truly paid by the said  
William Bonds at and before the sealing and delivery of these presents the  
receipt thereof the said Patrick Saffery doth hereby acknowledge and thereof  
and of and from every part and parcel thereof do acquit and discharge the said  
William Bonds his heirs and assigns, and for divers other good causes and consi-  
derations hereunto moving have granted, bargained, sold, aliened, enfeoffed and  
confirm unto the said William Bonds his heirs and assigns forever, all that parcel  
or tract of land lying and being in the above mentioned County on the South West  
side of Reddy River containing one hundred acres originally granted unto Patrick  
Saffery and signed by his Excellency William Montcrie *Esquire* on the fifth day of  
September one thousand seven hundred and eighty five as by apt and annexed  
to the said grant will more fully appear. Together with all and singular the
