The Following deed of Conveyance from Simcock Cannon to Daniel M'Junkin
was proven before George Salmon Esq^r and Ordered to be Recorded
Recorded this 29th day of December 1790

This Indenture made the eighteenth day of March in the year
of our Lord one thousand seven hundred & Ninety & in the Fourteenth
year of American Independence between Simcock Cannon of the County
of Greenville in the State of S^c Carolina of the one part & Daniel M'Junkin
of the County & State afores^d of the Other part Witnesseth that the said
Simcock Cannon for & in consideration of the sum of Fifty pounds lawful
money of the s^d State to him in hand paid by the Daniel M'Junkin
the Receipt whereof is hereby acknowledged he the s^d Simcock Can-
non hath Granted bargained sold aliened & Confirmed & by these pre-
sents doth Grant bargain sell alien convey & confirm unto the s^d
Daniel M'Junkin all that plantation or Tract of Land Situated
in the s^d County beginning at a Red Oak Running S. West Eighty Degrees
Twelve chains thence Red Oak thence & West twenty five degrees sixteen chains
to a pine & N. W. fifty one degrees sixty five chain to a post Oak thence
& N. W. forty five Deg. Twenty chain to a Spanish Oak thence & N. eighty
degrees seventeen chain to a Red Oak a conditional Corner thence along
a conditional line to a post Oak in a S. E. line of Eighty Two Deg. being
the first station post Oak in that line thence along S. line to a corner
State S. of thirty three Deg. thirty two chain along Daniel M'Junkins
line to a corner thence S. E. fifty seven degrees thirty five chain to the
beginning Red Oak containing one hundred & thirty acres more or less
being part of Two hundred & thirty acres of Land Granted to Simcock
Cannon by J. M. & deed with all & singular the houses out houses Barns
Stables Gardens Orchards woods under woods commons common of
pasture profits commodities advantages heridaments ways waters
water Courses appurtenances whatsoever s^d Tract of Land belonging
or in any wise appertaining & also the Reversion & Reversions

the only use & behoof of him the s^d Daniel M'Junkin his heirs & assigns
for ever & the s^d Simcock Cannon for himself his heirs & assigns the s^d
Granted premises unto the s^d Daniel M'Junkin his heirs & assigns whom
& will warrant & for ever defend by these presents In Witness whereof
the s^d Simcock Cannon hath set his hand & affixt his seal the day
& date first above written
