

Grant bearing date the fifteenth of October Anno Domini one thousand seven hundred & eighty four under the hand of his Excellency Benjamin Gurard Esq^r Governor & commander in chief in & over the said State having the great seal of s^d State thereunto affixed did give and Grant unto Thomas Ferrar a Tract of land containing Two hundred acres situate in s^d County on Beaver Dam Creek of Enore River and hath such form and marks as appears by a plat to s^d Grant annexed the said Grant being duly Recorded in the Secretaries Office Reference therunto had may more fully appear & Now this Indenture witnesseth that the said Edmund Peters did sell and convey unto s^d William Savage the one half of said Survey beginning at a stake on the dividing line & h^o 27 h^o 25 to a post Oak Corner thence S 27 E 40 to a black corner and S 69 h^o to the dividing line between Gerson Sutherland & s^d Peters which s^d one hundred acres sold and conveyed unto s^d William Savage he the said Edmund Peters for & in consideration of the sum of thirty Pounds Sterling & Money to him in hand Paid by the said Savage before the signing & delivering these Presents the Receipt whereof is hereby acknowledged have Granted bargained sold aliened conveyed & confirmed and by these presents doth Grant bargain sell alien convey & confirm unto the s^d W^m Savage the above described Tract of one hundred of Land Together with all & singular the woods under woods ways waters water courses Houses Buildings Gardens Orchard heridatements and Appurtenances unto the said Land belonging or in any wise Appurtenanting and also the Reversion or Reversions Remainder & Remainder Rents Issues and profits thereunto belonging to have & to hold the said Granted Premises of one hundred acres of Land unto the said W^m Savage his heirs & Adm^{rs} & assigns both Covenant & agree to & with the said W^m Savage his heirs & Adm^{rs} & assigns that he shall at all times hereafter peacefully & quietly Occupy possess and enjoy the said Tract of one hundred acres of Land above mentioned from all & every former bargain sales & mortgages Judgments Rights or dowers and all other Incumbrance whatsoever and that the said Edmund Peters his heirs and assigns will warrant & for ever defend the s^d Tract of one hundred acres of Land unto the s^d W^m Savage his heirs & Adm^{rs} & assigns from all and every other Person or Persons that shall Lay any title or claim Justly thereunto In Witness whereof the s^d Edmund Peters hath hereunto set his hand and affixed his seal the day and year above mentioned.

The following Deed of conveyance from John Buchanan to James Harrison Esq^r was proven before Mr. Alexander Esq^r produced in Open Court & ordered to be Recorded, which was done this 14th May 1791.

South Carolina

This Indenture made this fourteenth day of January in the year of our Lord one thousand seven hundred and ninety between John Buchanan of Camden District of the one Part, and James Harrison of Ninety six District and Greenville County of the Other Part Witnesseth that the said John Buchanan for and in consideration of the sum of Eight
