State S. Carolina, Know all men by these presents that I Laurence Brasher
of State aforesaid. Have sold and by these Presents do sell and release to Joseph
Jackson of State aforesaid a certain piece of land lying in Greenville District on the
S. side of the middle fork of Reedy River, containing one hundred acres more or less
Part of a tract of three hundred acres granted to S. L. Brasher, laid out to the
S. D. Jackson as follows. Beginning on a red oak thence N. 48 E. 5 ch. to a post oak
thence S. 55 E. 12 to a red oak thence N. 30 E. 35 to a hickory thence N. 25 W. 8
to a post oak thence N. 40 W. to a sacifras thence S. 43 W. to a maple thence
on the original line to the Beginning, including one hundred acres more or less.
Together with all that appertain, to the said land and Premises the S. Laurence
Brasher doth warrant the above land and premises to the said Joseph Jackson
his heirs and assigns from all claims that now is or may be made by any
Person claiming the same or any part thereof; In Witness whereof the said
Laurence Brasher doth hereunto set his hand this Eleventh day of July
One thousand Eight hundred and seven, signed in Presence of
us, John Croft. William M. Elroy Laurence Brasher

saw Laurence Brasher sign and deliver the within deed to Joseph Jackson
