made this ninth day of January in the year one Thousand eight  
hundred and thirteen between Michael Prewitt and Rachel Prewitt  
his wife of the said State and District aforesaid of the one part, and  
Prudence Erickson and John Erickson of the State and District aforesaid  
of the other Part. Witnesseth that the said Michael Prewitt and Rachel  
Prewitt his wife as well for and in consideration of the natural love and  
affection, she hath ana boreth unto the said Prudence & John Erickson  
they being the only Children of the said Rachel Prewitt one as for the sum of  
fifteen Dollars to them paid by the said Prudence & John Erickson the said  
Michael Prewitt and Rachel Prewitt his wife hath given granted and confirmed  
and by these presents doth give grant and confirm unto the said Prudence  
and John Erickson one tract of Land on a branch of Tyger River granted  
to Rachel Erickson and heris by Jonas Dawson adjoin land now owned by  
Abner Satter containing one hundred & fifty acres more or less, one more tract  
of land lying on the said branch adjoining the above tract containing  
one hundred acres, but in two Deeds bounded to us fifty each by  
Joseph King to us Baffeehan had to the Deed will admit of
