1883 Know all men by these presents that I Simpson Southern of the state South Carolina and District of Greenville have this twelfth day of September in the year of our Lord one Thousand Eight Hundred & seven have for and in consideration of the sum of one hundred Dollars to me in hand paid by James Smith of the aforesaid state & District have granted bargained sold and by these presents do grant, bargain, sell unto the said James Smith a certain tract or piece of land containing fifty acres be the more or less Beginning on a post oak corner clear corner thence down the hill to a white oak corner near said Southern's Spring thence to a pine corner near the Spring thence to a white oak corner on the branch above the spring thence up said branch to the third Branch into into said Branch thence up the south fork of said Branch to Martin axes line thence to a black oak corner on Abram Markely line thence with s^d Markely line to a white oak corner made between W. Southern & M. Elrod thence down the first fork of s^d Branch to a holly thence to a stake made between Southern & Elrod thence to the Beginning s^d tract containing fifty acres more or less Together with all and singular rights members hereditaments and appurtenances thereunto belonging or in any wise incident or appertaining to have & to hold all & singular the premises before mentioned and sold unto the s^d James Smith his heirs and assigns for ever in fee simple and I do bind myself my heirs Executors & adm^rs. to warrant on for ever defend all and singular the aforesaid premises unto the said James Smith his heirs and assigns against myself my heirs and all
