Love testified for the 5<sup>th</sup> of August 1786 the aforesaid tract or parcel of Land containing two hundred and twenty six acres (less or more) situate lying on Eisha Thompston River dam Creek waters of Middle Tyger River in the District aforesaid Beginning at a post Oak N. 25. Ch. to a large Red Oak Thence W. 36. Ch. to a small pine. Thence N. 30. W. 12. 50. to P. O. Thence S. 80. W. 12. 50 to a Black Oak. Thence S. 10. W. 48. 50 to a small pine, Thence S. 80. W. 27. 50. to a small post oak Thence to a stake on James Smith line. Thence N. along James line to a post oak Thence E. 40 to a post oak Thence N. 70.
