Together with all woods, trees waters water courses for profits Commodities appertinances and hereditaments whatsoever thereunto belonging or in any wise appertaining to have and to hold, The said tracts before mentioned of one hundred and twenty two and one hundred & twelve acres of land and all and singular other the premises and improvements thereon to said John Davis his heirs Executors administrators and assigns for ever and the said Michael Walling do hereby bind himself his heirs Executors adminrs. to warrant and for ever defend from the Claims of all and Every person or persons whatsoever laying any Claim to any part or part thereof, of the before mentioned premises. In Witness whereof the said Michael Walling hath hereunto set his hand and affixed his seal this nineteenth day of December one thousand Eight hundred and three. W 12. 50 to a red o. stump near a branch on land granted to Daniel Birch, Thence S 64 W. 28 to a stake by a pine Joining land granted to John Hunt, Thence N 25 E. 86. 60. to a red o x Joining land granted to James Blappingame Thence S 70 E. 19. 70 to a Stake on the road on said Blappingames land Thence along said road to the beginning containing one hundred and twenty three acres. The said land being a part of a tract originally granted to John Hunt the fourth of June In the year of our Lord one thousand seven hundred and ninety two.
