



The State of South Carolina Know all men by these Presents that I Waddy Thompson of Greenville District in the State aforesaid for and in consideration of the sum of six hundred dollar, to me in hand paid by Henry Middleton Esq. of the same place, Have granted bargained sold and released, and by these Presents do grant bargain sell and release unto the said Henry Middleton one certain Plantation or Tract of Land containing one hundred and eleven acres, more or less, lying and being in the district aforesaid on the waters of Richland Creek being part of a tract originally granted to John Timmons, beginning at Goodlett's Corner on a red oak, thence running N. 45 E 25 ch^s crossing Richland Creek to a red oak Corner on said Goodlett's line thence S. 45 E 30 ch^s & 50 links to a Chestnut Corner thence S. 45 W. to a Stake at Richland Creek thence N. 70 W. 20 chains to a Stake, thence to the beginning. Also one other Tract of Land containing one hundred and eighty two acres, more or less, adjoining the above originally granted to David Goodlett, beginning at a black oak Corner on the West side of Richland Creek, thence running N. 45 E. to a Pine Corner on David Luster's line thence S. 70 E 34 ch^s to a black oak Corner on Watson's line thence S. 35 W. 6 ch^s & fifty links to a Stake corner thence S. 50 E. to a Hickory Station on J. Watson's line near a branch, thence S. 45 W. to Attons Corner (a red oak) thence to the beginning. Together with all and singular the rights, members, hereditaments, and appurtenances to the said premises (except the privilege of the water course of Richland Creek which was reserved by David Goodlett in his Deed of Conveyance to Alexander Waddell to build a mill on) belonging or in any wise incident appertaining. To have and to hold all and singular the premises before mentioned to the said Henry Middleton his heirs and assigns forever. And I do hereby bind myself my heirs, executors & administrators to warrant and forever defend all and singular the said premises unto the said Henry Middleton his heirs and assigns against myself & my heirs and against the claim or claims of every other person or persons whatsoever — Witness my hand and seal this 18th day of November 1814.
