This Indenture made this fourteenth day of September in the year of our Lord one thousand eight hundred & fourteen, between John Wood Sheriff of Greenville district of the state of our said of the one part, and Stephen Dill of the other part. Whereas by virtue of a writ of fieri facias, which issued from the Court of Common Pleas at Greenville Courthouse, at the suit of the Administrators of John Earle against the Executors of John Gowen, directed to all & singular the Sheriffs of S^c. State Greeting, which execution was duly entered in the Sheriff's office of S^c. District, the said Wood did enter upon and seize under the said Execution a certain tract or parcel of land herein after described & after Notice of the intended Sale of said land did on the fourth day of October in the year of our Lord one thousand eight hundred & thirteen openly publicly and fairly according to the custom of our said expose (subject nevertheless to all legal incumbrances) the to sale to the highest bidder at Greenville Courthouse in the district aforesaid, and the said land being so exposed was struck off to the said Stephen Dill for the sum of twenty Dollars, he being the highest and last bidder for the same. NOW this Indenture Witnesseth that the said John Wood as Sheriff of Greenville district as aforesaid in consideration of the sum of twenty dollars to him in hand paid by the said Stephen Dill the receipt whereof is hereby acknowledged hath granted bargained and sold and by these presents do grant bargain and sell unto the said Stephen Dill sixty acres of land more or less, lying and being in the district aforesaid, on the Waters of Tyger River bounded South by Edwarda Stewarts land, North by Abraham Thompsons land, N. W. by Ann Earleys line (it is said) to begin on a red oak N 10 E. 24 chs 50 to a post oak, N. 66. E. 72 chs 50 to a White Oak, S. 50 E. 31 chs to a Hickory, S. 18 chs to a Stake N. 50 W. 16 chs 50 to a Chestnut, S. 7 S. W. 26 chs to a red oak, S. 8 chs 50 to a Post oak thence with last line S. 80 W. to the beginning; with all and singular the rights members and appurtenances to the said land belonging or in any wise appertaining; & all the right title claim or interest the said Gowen had in S^c. land at the time of Sale: to have and to hold the said Tract of land unto the S^c. Stephen Dill his heirs and assigns forever (subject as above mentioned) In Witness whereof John Wood Sheriff as aforesaid have here unto set my hand and Seal this 8th of October in the year of our Lord 1814
