Together with all and singular the rights members hereditaments and appertainments to s^d premises belonging or in any wise appertaining; To have and to hold all and & singular the premises before mentioned unto the said Robert Nelson Junr. his heirs and assigns forever, and I do hereby bind myself my heirs executors & administrators to warrant and forever defend all & singular the said premises unto the said the said Robert Nelson Junr. his heirs & assigns against myself my heirs and against every other person whatsoever, claiming or to claim the same or any part thereof. in Witness whereof I have here unto set my hand and seal this fifteenth day of February one thousand eight hundred & fifteen & in the thirty eighth year of the independency, of the United States of America - Signed, Sealed & delivered in presence of us test.
