of Greenville district in the State aforesaid in consideration of one hundred & Sixty seven
dollars, & Sixty Six cents to me in hand paid by David Henning of the District &
State aforesaid, HAVE granted bargained sold and released, and by these presents
do grant bargain sell & release unto the said David Henning a Lot of land in the
Village at Greenville Court house supposed to contain about one third of an acre
be the same more or less, lying to the South of Doc^t. Britten's Lots, and being
the South ends of two lots known and distinguished in the Plan or Chart of the
said Village by the numbers five and six (N^o. 5 & 6.) and fronting fifty two & an
half feet on the N.E. corner of the public square. Beginning on a Stake, running
thence N. 15^o E. fifty two and an half feet to a Stake, thence S. 74^o E. two hundred
feet to a Stake, thence S. 15^o W. 52^o feet to a Stake, on the side of the Street above
the Goal, thence N. 74^o W. 200 feet to the beginning. Together with all & singular
the rights members hereditaments & appurtenances, to the said premises, belonging
in any wise incident or appertaining, To have and to hold all and singular the premises
before mentioned unto the said David Henning his heirs & assigns forever. And I do
hereby bind myself my heirs executors & administrators to Warrant & forever defend
all & singular the said premises unto the said David Henning his heirs & assigns against
myself, and my heirs, and against every person whomsoever lawfully claiming or to
claim the same or any part thereof. Witness my hand and Seal this twenty

above State & District, bounded as follows, Beginning corner at S. Is. Fowler's Spring on
a Spanish Oak stump thence down Gilders with it to Holland's line corners there thence
with S. Holland's line to a Conventional Stake Corner thence straight to the beginning Oak
Stump. Together with all & singular the rights members hereditaments & appurtenances, to
have & to hold all & singular the premises before mentioned unto the said Israel Fowler
his heirs & assigns forever. And I do hereby bind myself my heirs Exors & adm^s
to warrant & forever defend all & singular the S. premises unto the S. Israel
