 Granted bargained Sold and Released & by these presents
 Do grant bargain Sell and Release unto the S^r. Henry
 Robertson all that tract or parcel of land containing two
 or three Acres or there some more or less Situated lying and
 being in the District of Greenville on both Sides of Armstrongs
 Creek part of a tract of land formerly the property of Joseph
 Neasinove and conveyed to me by S^r. Neasinove beginning on
 a white Oak Corner Conditional between James Robertson &
 Said Henry Robertson thence down Said Branch to Armstrongs Creek
 thence down Said Creek to a white oak Corner new maid between Finley
 & Robertson thence a conditional line to a hickory corner on the East side
 of Said Creek thence up Said Creek to a Stake on the west Side of Said Creek thence
 a conditional line to a Black Oak Corner on James Robertson line thence with
 Said Robertson to the beginning Corner Together with all & Singular the rights
 members hereditaments & appertinances to the S^r. premises belonging or in any
 Incident or appertaining to have and to hold all & Singular the premises before
 aforesaid unto the Said Henry Robertson his heirs & assigns forever and I do here by binding
 myself
